#### COMMENTS:

Noble respectfully request to change the TPZ and BHL of the proposed wellbore. The lateral will shift to the west to move away from an existing horizontal well (Dechant State 36N-E1HZ). The total depth has changed to 11921', and casing and cement program has been updated. This move did not result in any additional wells to the Off-set well evaluation. The PWE spreadsheet has been updated to show that there were no changes.
