Comment: There are noxious weeds (Scotch thistle) along the access road. The weeds have developed seed heads and need to be cut, bagged, and removed. Scotch thistle is a biennial plant and first years rosettes were also found which need to be controlled. Vegetation along the reclaimed access road is establishing well in areas. Operator must monitor and manage the site to prevent noxious weed infestation or other issues. See attached photos
