While there, I observed a producing facility.  During this inspection the following possible compliance issues were observed:</p> <ol style="list-style-type: none"> <li>1. Stained soil at master valve on two wellheads (ANDREWS 26-13, ANDREWS 26-14) SECURELY FSTEN ALL VALVES, PIPES AND FITTINGS TO ENSURE GOOD MECHANICAL CONDITION, INSPECT AT REGULAR INTERVALS AND MAINTAIN IN GOOD MECHANICAL CONDITIONS PER RULE 605.D. (Corrective Action Date: October 18, 2019) See attached photo #3 in individual wellhead photos.</li> <li>2. No BBLS labeled on H2O tank. INSTALL SIGN TO COMPLY WITH RULE 210.D. (Corrective Action Date: October 18, 2019) See attached photo #4 in location photos.</li> <li>3. Unused risers (LOTO) next to separator. COMPLY WITH RULE 603.F.
