This is a follow-up good housekeeping inspection.

On 9/20/2019, Reclamation Specialist Trujillo conducted an inspection at Noble's Peterson PC LG 19-06 location #422755 in Weld County, Colorado.

This inspection is a follow-up inspection to #696200360 dated 7/8/2019, #696200564 dated 8/08/2019 and #696200604 dated 8/16/2019 to document compliance for the following corrective actions:

1003.f: Noxious weed management

During this inspection, it was observed that the Operator appears to have conducted mowing operations, however, operator has failed to conduct sufficient noxious weed management in an appropriate time frame to prevent seed dispersal from mature plants, and the possible spread of Canada Thistle along the access road and adjacent lands. Viable weeds remain on the location

It was observed in this inspection that operator appears to have conducted mowing operations, however mowing operations appear insufficient as individual Canada thistle plants with mature seed heads, as well as viable Canada thistle rosettes, remain on the location.

 Operator has failed to conduct sufficient noxious weed management to properly manage/remove weeds. Original corrective action and date remains applicable.
