COMMENTS:

During annual testing this well was found to have BH pressure exceeding the actionable threshold for surface casing set deeper than 455' (doc #402137660) and a sample was collected (doc #402156405). We would like to plumb the bradenhead to a temporary tank to keep the pressure below 50 PSI for a 5-week period, in hopes that it dissipates. After the blowdown period, we will conduct a buildup test and re-evaluate if further action is required.
