Location was constructed and according to Operator, Surface Casing set; which was Closed/Plugged when Permit was Abandoned. There are no records in Document files detailing Surface casing (Spud), Conductor setting or Plugging/Closing work or dates. Well can not be released for Final Reclamation until Documentation issues are resolved.

Site does not appear fully re-contoured; however on reviewing aerials site has, pre O&G, been conformed as a basin/ bowl sitting below a water feature and general contours were not disturbed by O&G activities.
