<p><b>COGCC Inspection Report Summary</b>  On Wednesday, October 2, 2019 at approximately 12:45, I, Inspector Brittani Santistevan, conducted an on-site inspection at GREAT WESTERN 26-23, 53 (Great Western Oil &amp; Gas), at location #: 333028 in WELD COUNTY Colorado.  While there, I observed temporarily abandoned wellheads/shut in facility.  During this inspection the following possible compliance issues were observed:</p> <ol style="list-style-type: none"> <li>1. Great Western 26-23 has wrong sign on fencing. <b>INSTALL SIGN TO COMPLY WITH RULE 210.B. (Corrective Action Date: November 2, 2019) See attached photo #3.</b></li> <li>2. Inadequate berms surrounding tank battery; according to COGCC maps, location is in flood plains. <b>COMPLY WITH RULE 603.H.(2).C. (Corrective Action Date: November 2, 2019) See attached photo #6.</b></li> <li>3. Tanks/separator are not anchored; according to COGCC maps, location is in flood plains. <b>COMPLY WITH RULE 603.H.(1).C. (Corrective Action Date: November 2, 2019) See attached photo #6, 8.</b></li> <li>4. Produced water tank does not contain NFPA placard. <b>INSTALL SIGN TO COMPLY WITH RULE 210.D. (Corrective Action Date: November 2, 2019) See attached photo #7.</b></li> </ol> <p>BBLS are fading on all tanks, recommend re-labeling all tanks.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
