While there, I observed Wellsite. Reports show it as SI at the time of the inspection it appears to be SI, all service line appear to be disconnected. It also shows it to be an Extraction well but the WH sign shows KP Kauffman information.

During this inspection the following compliance issues were observed:

Weeds: weeds overgrown around WH and location, Comply with Rule 603.f 10 days for weeds. CA date 10/3/2019 see photos #1, 2 and 3.

Signs: WH sign shows wrong operator information, Comply with Rule 210.e 30 days if missing 24 hour operator contact number and/or local emergency contact. CA date 10/23/2019 See photo #1.

Location is dry, weather is cloudy.
