Operator Comment: 2 professional created weed plans have been submitted per Mr. Costas guideline and recommendation. The first one submitted was created by Les Dhaseleer, Environmental Specialist for Vermejo Park Ranch. The second plan submitted was created by Mr. Johnnie Hamilton of Southeast Environmental Services, LLC. Mr. Hamilton was recommended by Bob Lucero Las Animas county weed inspector. If the second plan is not approved I will need very specific details as to what else the COGCC is looking for. I forwarded the communications that Mr. Costa and I had in regards to the plan so the second plan could be completed per his guidance as Rule 1003.f. contains 5 sentences in regards to what the COGCC wants.

COGCC Decision: Approved pending re-inspection

COGCC Representative: The second submitted weed plan appears to provide mostly non-pertinent information regarding Wapiti's ongoing weed control. It is unlikely that performing weed control once annually will be sufficient. As a condition of approval of the weed control plan, Wapiti must: 1. Monitor and conduct weed control throughout the growing season.
2. Perform noxious weed control in the early Summer and Fall as recommended by the contractor in the weed control plan.
3. Perform Integrated Weed Management such as but not limited to physical, cultural, and chemical control. Submittal of the Weed Control plan does not preclude enforcement action. Ongoing inspections will be performed to evaluate compliance of Rule 1003.f.

Comment: The weeds were cut and removed. Spring of 2020 herbicide will be applied per the weed plan submitted. See attached photos
