Corrective Action:	Comply with 1004 Rules Remove pipe risers, equipment, and cement pad. Reclaim disturbed areas with inadequate crop growth. This may require soil sampling and adding soil amendments per the sampling results. Ensure soils are properly decompacted to 18 inches and suitable for crop growth.
