There maybe soil issues that is impacting vegetation growth. The access road does not have adequate vegetation and consists of predominately undesirable weeds (Kochia sp.). The weeds are 2 ft. tall in areas and are very dense. It does not appear that any reclamation work has been performed. The weeds have not been controlled. The corrective action of the previous inspections have not been performed. Previous corrective action date remains for possible enforcement. SEE ATTACHED PHOTOS</p> <p style="color: red; font-size: small;">Comply with 1004 Rules. Control weeds and remove weed debris. Ensure soils are properly decompacted to 18 inches and suitable for vegetation growth. This will require soil sampling and adding soil amendments per the sampling results.
