Comment: Operator indicated that this site had not; in an independent assessment met the 80% reference criteria to Pass Final Reclamation. Overall, site does not appear to be progressing, bare areas remain, exacerbated by Prairie dog (?) burrowing. Though it is apparent weed control program is in place, noxious weed rosettes are emerged in bared areas as well as population of ruderal, debris weeds.

Corrective Action:	Assess vegetation & site conditions in Fall 2019. Apply remedies /conduct reclamation activities needed, AS indicated by assessment, to ensure the uniform establishment across the site of desirable vegetation.
