Comment: **This location is not in compliance with Rule 1004. The well location has not been properly re-contoured to match the surrounding landscape and/or potential subsidence occurred.**

Appears a recent disturbance has taken place near the offsite tank battery location and crops have already been harvested; therefore, COGCC staff could not make a vegetative assessment for the tank battery location. Refer to the attached inspection photos.
