Comment: This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 03/22/2018. Operator has failed to remove all equipment, remove gravel and perform final reclamation activities at the tank battery location. Operator has failed to properly recontour the well location and well location access road. Refer to the attached inspection photos.

Corrective Action:	Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
