I, Inspector Robbie Revas, Conducted an on-site inspection at the Sam Funakoshi A #1& #2 Tank Battery KP Kauffman, at Location #318417 in Weld County Colorado.</p> <p>While there, I observed a Tank Battery. this is a follow up inspection per Doc.#699300194 During this inspection the following compliance issue has not been addressed and is delinquent:</p> <p>Housekeeping: weeds growing on the TB berm and by the heated horizontal separator are mostly dead and becoming debris. Comply with Rule 603.f. CA date 9/27/2019 see photos #2, 3 and 4.</p> <p>During this inspection the following compliance issue appears to have been addressed:</p> <p>Housekeeping: Stained soil around production lines by gas meter see photo #5.
