**General Comment:**

On 10/08/2019, Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

-As described during September 2019 inspection, topsoil stockpile is not stabilized or protected. Corrective action is not addressed. Interim reclamation needs to be conducted during the fall 2019 seeding window. Topsoil retained for final reclamation needs to be stabilized and protected, with stormwater and erosion controls until stabilized with perennial vegetation, and stored in a manner that is protective of topsoil microbial activity and prevents weed establishment.

-Bare soils on cut-slopes are not protected. Slope angle appears too steep to support revegetation. Slopes need to be stabilized during interim reclamation and no later than 10/31/2019.

**Location Construction**

**Comment:** Topsoil stockpile is not stabilized. Wattle around the perimeter of the pile is not sufficient to contain potential discharge, nor is it properly installed/maintained as erosional rilling and sediment discharge observed beneath the wattle. Bare soils on stockpile are not protected from erosion. Additionally, topsoil is not protected. Soil stockpile is approximately 10 feet high. Soils are largely bare or supporting annual weedy vegetation. This storage method is not consistent with protecting microbial activity within the soil stockpile as it is too deep.

**Corrective Action:** Interim reclamation needs to be conducted during the fall 2019 seeding window. Topsoil that is retained for final reclamation shall be protected using short term and long term stabilization methods, such as use of straw mulch crimped into the soil, stormwater controls, and revegetation. Corrective action is backdated to start of construction date as topsoil protection should be initiated at that time.
