Comment: [Summit Midstream meter house facility \(in use for other wells\) remains on location. General Site suffers from Cheat grass infestation and Kochia/Mustard establishment at Meter house vicinity. Desirable species are establishing, but are overgrown by Cheat grass, and visually would not meet the 80% requirement. Operator indicated that Cheat grass had been treated twice and that controls would continue and scheduling of Vegetation assessment to determine progress of desirable vegetation.](#)
