Operator Comment: Operator built dirt berms (secondary containment) around perimeter of pad by 12/21/18. Straw wattles (tertiary containment) were placed and staked by 12/27/18. Sediment traps, enforced with rip-rap were completed at two outfall locations on the downslope of the pad on 12/28/18. Culverts and rip-rap were placed in downgrade areas of the creek crossing by 12/29/18 and an elevated speed bump constructed from road base was installed across the down-grade of the pad (at the road exit) on 1/5/19.
