Operator Comment: After collaborating with the landowner on 10/28/19, he said he does not want SRC to do anything to the wellhead location or the production facility as there is good growth in both areas. Although there is a little bit of subsidence, he indicated the drainage is good and there are no ponding issues so there is no reason to try and fix the area. The landowner mentioned that SRC will do more harm than good. The recent disturbance at the

production facility is due to the harvesting of corn and they use the road between the alfalfa and corn for truck access in and out. The road is used for their agricultural purposes.
