Comment: Site vegetation is composed mainly of C List Noxious Weeds, including heavy infestation of Cheat grass, lesser populations of Bulbous bluegrass and Redstem filaree. Among other ruderal weedy species on site are Tumble mustard, Pepperweed, Madwort, Sweet Clover. Desirable species are present, but are overwhelmed by weedy species and do not have a uniform establishment across the site.
