This refiled APD is being submitted to update the following: SHL, TPZ, BHL, DRILLING & SPACING UNIT.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 750' FSL and 2350' FWL of Section 23. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

Nearest wellbore permitted or completed in the same formation is the Hale 8-60 22-23-12 (Bison Oil & Gas II, LLC), measured using 2D manual calculations.

Nearest existing or permitted wellbore belonging to another operator is the STANLEY #14-23 API 05-123-10707 (CARRIZO NIOBRARA LLC), measured using 3D manual calculations. The well status is DA.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The purpose of this is to prevent the wear and tear on the choke line and kill line valves. The annular and double rams will be tested as per usual and all broken connections will also be tested (annular to 70% of rated pressure, all other valves and connections will be tested to full rated pressure).</p> <p>Under no circumstances will 21 days be exceeded without completing a full BOPE test to all connections including all choke and kill line valves. Daily function test / activation of pipe rams are still required in addition to a preventer operator test on each trip.</p>
