Comment: COGCC staff observed a 60 feet by 60 feet by 20 feet deep excavation around the point of release (See photos). The Operator was stockpiling the impacted soil on location northwest of the excavation (Approximately 2700 cubic yards). COGCC staff (John Heil) conducted had a meeting with the Operator (Natalie Stiner) in which COGCC staff was informed that historical impacts were discovered while excavating the impacts from Spill 468668.

Corrective Action: Operator shall submit a Form 19 Initial/Supplemental (Spill Type: Historical) with request for closure to address the historical impacts.  
Operator shall submit a Form 19 Supplemental to close the spill under a Form 27.  
Operator shall submit a Form 27 Site Investigation and Remediation Workplan to delineate vertical and horizontal impacts.
