**Environmental****Spill/Remediation:**

Comment: Former produced water pit has been partially backfilled. A siphon pipe requires removal and disposal. A former berm that partially divided the produced water pit is not three feet below grade. The surface of the berm requires sampling and analysis of pH, EC and SAR prior to being backfilled in place.

Corrective Action: Collect two surface soil samples from the berm north and south of the siphon pipe for pH, EC and SAR laboratory analysis for submittal on a supplemental Form 27
