The trailers cited in the inspection report are construction trailers that are in use and specifically placed as part of the SUA with the surface owner and Operators Agreement with the City and County of Broomfield. They were specifically placed there to minimize the disturbance to the undisturbed surface land by using the existing access road and disturbed area. Rule 603.f. regarding serviceable equipment does not require any approval from the COGCC. Rather, as outlined in the COGCC Guidance on the 603 rules, approval is placed on the local or county body (Section B.b. of the guidance). Extractions Operator Agreement is reflective of local and county approval. This agreement is further supported by the Surface Use Agreement with McWhinney (surface owner).
