**Comments:**

This is a corrective action response to field inspection report dated 6/25/2019, Document Number 696200314. After consultaion with the surface owner and the field inspector, we hauled in topsoil to cover the area needing additional reclamation. On 7/19/2019 we used a grass drill to seed the area to be reclaimed with a pasture grass seed mixture. For erosion control we covered the re-seeded area with straw and then tucked in the straw using a vertical disc. We will continue to monitor the reclaimed area until sufficient re-vegetation is achieved and then request a final reclamation field inspection.
