

ASSIGNMENT, BILL OF SALE AND CONVEYANCE

This Assignment, Bill of Sale and Conveyance (this "*Assignment*"), effective as of March 1, 2019, at 12:00 a.m., Mountain Time (the "*Effective Time*"), is from **Caerus WashCo LLC**, a Colorado limited liability company, and **WeldCo Resources LLC**, a Delaware limited liability company, (collectively, "*Assignors*"), both with an address of 1001 17th Street, Suite 1600, Denver, CO 80202, to **Bison Oil & Gas II, LLC**, a Colorado limited liability company ("*Assignee*"), with an address of 518 17th Street, Suite 1800, Denver, Colorado 80202. Assignors and Assignee are, individually, a "*Party*," and are, collectively, the "*Parties*."

For Ten Dollars (\$10.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors grant, bargain, sell, convey, assign, transfer, and deliver unto Assignee all of Assignors' right, title, and interest in and to the Assets, to have and to hold unto Assignee and its successors and assigns, forever, subject to the following terms and conditions:

1. Assets. As used herein, the term "*Assets*" (less and except the Excluded Assets) refers to all of Assignors' right, title and interest in and to the following:

(a) The leasehold estates created by the oil and gas leases described in Exhibit A-1 ("the "*Leases*"), and the hydrocarbons and non-hydrocarbons ("*Hydrocarbons*") attributable to or produced from the Leases or the lands pooled, unitized, or communitized therewith (the "*Lands*"), and all other right, title, and interest of Seller in and to the Leases, Hydrocarbons, and Lands;

(b) the oil, gas, monitoring, or injection wells located on the Leases or Lands, whether producing, operating, plugged, abandoned, shut-in or temporarily abandoned, including the wells described in Exhibit B-1 (collectively, the "*Wells*"), the pipelines and facilities associated or used in connection with the Wells, and all real property, tangible personal property, equipment, fixtures, improvements, permits, rights-of-way, easements, and other rights to use the surface (including those rights-of-way, surface use agreements, and easements described in Exhibit B-2), in each case used or held for use in connection with the exploration, development, production, gathering, treatment, handling, processing, storing, transporting, sale or disposal of Hydrocarbons or water produced from the properties and interests described in this Section 1, including all equipment installed on the Leases, Lands, or Wells as of the Effective Time;

(c) the unitization, pooling, and communitization agreements, declarations and orders, and the units created thereby and all other such agreements relating to the properties and interests described in this Section 1 and to the production of Hydrocarbons, if any, attributable to said properties or interests (the "*Units*," and, together with the Leases, Lands, and Wells, the "*Properties*");

(d) the approved Colorado Oil and Gas Conservation Commission Applications for Permit to Drill listed on Exhibit B-3;

(e) all existing and effective agreements or contracts to which Assignors are a party (directly or as successor-in-interest to another Person) or by which the assets and properties described in this Section 1 are bound which are listed on Exhibit C to the Purchase Agreement (collectively, the "**Contracts**"), only insofar as such Contracts relate to or are otherwise applicable to the assets and properties described in this Section 1;

(f) the files and records in the manner currently maintained by Assignors to the extent directly related to the interests described in this Section 1, and all digital well files maintained by Assignors (subject to the Excluded Assets, the "**Records**"); and

(g) all rights, claims, and causes of action to the extent attributable to the interests described in Section 1, insofar as such interests arise on, or after the Effective Time or relate to any Assumed Liabilities.

2. Excluded Assets. The Caerus Assets do not include, and there is hereby expressly reserved to Seller, the following assets and properties (the "**Excluded Assets**"):

(1) all rights, claims, and causes of action, whether arising before, on, or after the Effective Time, to the extent such rights, claims, and causes of action relate to any of the Retained Liabilities or any of Seller's indemnity obligations under this Agreement;

(2) any accounts receivable, trade accounts, accounts payable or any other receivables affecting the interests described in Section 1 accruing before the Effective Time;

(3) all corporate, financial, tax, and legal (other than title) records of Seller;

(4) all contracts of insurance and master service agreements;

(5) all Hydrocarbons from or attributable to the Caerus Assets with respect to all periods prior to the Effective Time, and all proceeds attributable thereto;

(6) all claims for refunds of Seller Taxes attributable to the ownership or operation of the Caerus Assets prior to the Effective Time, except to the extent such Taxes resulted in a downward adjustment in the final determination of the Final Purchase Price);

(7) all documents and instruments of Seller (or any affiliate of Seller) that are (1) except for title opinions, subject to legal privilege (such as the attorney-client privilege or work product doctrine) or contractual restrictions on disclosure or transfer, (2) interpretive or subjective data, (3) personnel information, (4) Income Tax information, (5) records relating to the sale of the Caerus Assets, and (6) information relating to litigation and claims retained by Seller;

(8) all seismic records, interpretive maps, gravity maps, gravity meter surveys, seismic surveys, and other similar geological or geophysical surveys or data, including any processed or reprocessed data; and

(9) the files, records and data maintained by Seller and relating to the Caerus Assets that are maintained on Seller's or its affiliates' e-mail servers.

3. Purchase Agreement: No Merger. This Assignment is made pursuant to and subject to the terms of that certain Purchase and Sale Agreement dated March 15, 2019, between Assignors and Assignee (the "*Purchase Agreement*"). If there is a conflict between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall control to the extent of the conflict. Capitalized terms used and not defined in this Assignment shall have the meanings assigned to them in the Purchase Agreement. None of the provisions of the Purchase Agreement shall be deemed to have merged with this Assignment.

4. Warranty of Title. Subject to the terms of the Purchase Agreement, Assignors warrant Defensible Title to the Assets from and against all persons claiming by, through and under Assignors, but not otherwise. Assignors hereby represent and warrant to Assignee that Assignors have not assigned, transferred, mortgaged, pledged or otherwise encumbered any of its right, title and interest in, to and under the Assets.

5. Assumption and Retention. Subject to the terms of the Purchase Agreement, as of the Effective Time, with respect to each of the Assets, Assignee does hereby assume and agree to pay, perform, fulfill and discharge all Assumed Liabilities. Assignors shall retain and shall pay, perform, fulfill and discharge the Retained Liabilities.

6. Further Assurances. Assignors and Assignee shall execute, acknowledge and deliver all other additional instruments, notices, and other documents and to do all other further acts and things as may be necessary to more fully and effectively assign, transfer and convey the Assets to Assignee and accomplish the purposes of this Assignment.

7. Disclaimers.

(a) EXCEPT FOR ASSIGNORS' EXPRESS REPRESENTATIONS AND WARRANTIES CONTAINED IN THE PURCHASE AGREEMENT, AND ASSIGNORS' SPECIAL WARRANTY OF DEFENSIBLE TITLE IN THIS ASSIGNMENT, THE ASSETS ARE BEING CONVEYED BY ASSIGNORS TO ASSIGNEE WITHOUT WARRANTY OF ANY KIND, EXPRESS, IMPLIED, STATUTORY, COMMON LAW OR OTHERWISE, AND THE PARTIES HEREBY EXPRESSLY DISCLAIM, WAIVE, AND RELEASE ANY EXPRESS WARRANTY OF MERCHANTABILITY, CONDITION, OR SAFETY AND ANY EXPRESSED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; AND ASSIGNEE ACCEPTS THE ASSETS, "AS IS, WHERE IS, WITH ALL FAULTS, WITHOUT RECOURSE." ASSIGNEE EXPRESSLY WAIVES THE WARRANTY OF FITNESS AND THE WARRANTY AGAINST VICES AND DEFECTS, WHETHER APPARENT OR LATENT, IMPOSED BY ANY APPLICABLE STATE OR FEDERAL LAW.

(b) EXCEPT FOR ASSIGNORS' EXPRESS REPRESENTATIONS AND WARRANTIES IN THE PURCHASE AGREEMENT, AND ASSIGNORS' SPECIAL WARRANTY OF DEFENSIBLE TITLE IN THIS ASSIGNMENT, ASSIGNORS HEREBY EXPRESSLY DISCLAIM AND NEGATE ANY IMPLIED OR EXPRESS WARRANTY AT COMMON LAW, BY STATUTE OR OTHERWISE RELATING TO (1) THE ACCURACY, COMPLETENESS OR MATERIALITY OF ANY OF THE RECORDS OR OTHER INFORMATION FURNISHED WITH RESPECT TO THE PURCHASE AGREEMENT; (2) THE EXISTENCE OR EXTENT OF RESERVES OR THE VALUE OF THE ASSETS BASED THEREON; (3) THE CONDITION OR STATE OF REPAIR OF ANY OF THE ASSETS; (4) THE ABILITY OF THE ASSETS TO PRODUCE HYDROCARBONS, INCLUDING PRODUCTION RATES, DECLINE RATES AND RECOMPLETION OPPORTUNITIES; (5) REGULATORY MATTERS; (6) THE PRESENT OR FUTURE VALUE OF THE ANTICIPATED INCOME, COSTS OR PROFITS, IF ANY, TO BE DERIVED FROM THE ASSETS; (7) THE ENVIRONMENTAL CONDITION OF THE ASSETS; (8) ANY PROJECTIONS AS TO EVENTS THAT COULD OR COULD NOT OCCUR; OR (9) THE TAX ATTRIBUTES OF ANY ASSET.

(c) THIS DISCLAIMER AND DENIAL OF WARRANTY ALSO EXTENDS TO ANY EXPRESS OR IMPLIED REPRESENTATION OR WARRANTY AS TO THE PRICES ASSIGNEE AND ASSIGNORS ARE OR WILL BE ENTITLED TO RECEIVE FROM PRODUCTION OF OIL, GAS OR OTHER SUBSTANCES FROM THE ASSETS. ALL RESERVE, PRICE AND VALUE ESTIMATES UPON WHICH ASSIGNEE HAS RELIED OR IS RELYING HAVE BEEN DERIVED BY THE INDIVIDUAL AND INDEPENDENT EVALUATION OF ASSIGNEE. ASSIGNEE STIPULATES AND AGREES THAT RESERVE REPORTS ARE ONLY ESTIMATES OF PROJECTED FUTURE OIL AND/OR GAS VOLUMES, FUTURE FINDING COSTS, AND FUTURE OIL AND/ GAS SALES PRICES, ALL OF WHICH FACTORS ARE INHERENTLY IMPOSSIBLE TO PREDICT ACCURATELY EVEN WITH ALL AVAILABLE DATA AND INFORMATION.

(d) EXCEPT FOR ASSIGNORS' EXPRESS REPRESENTATIONS AND WARRANTIES IN THE PURCHASE AGREEMENT, ASSIGNORS HAVE NOT AND WILL NOT MAKE ANY REPRESENTATION OR WARRANTY REGARDING ANY MATTER OR CIRCUMSTANCE RELATING TO ENVIRONMENTAL LAWS, THE RELEASE OF MATERIALS INTO THE ENVIRONMENT OR THE PROTECTION OF HUMAN HEALTH, SAFETY, NATURAL RESOURCES OR THE ENVIRONMENT, OR ANY OTHER ENVIRONMENTAL CONDITION OF THE ASSETS, AND ASSIGNEE SHALL BE DEEMED TO BE TAKING THE ASSETS "AS IS" AND "WHERE IS" WITH ALL FAULTS FOR PURPOSES OF THEIR ENVIRONMENTAL CONDITION.

(e) THE PARTIES HEREBY ACKNOWLEDGE AND AGREE THAT, TO THE EXTENT REQUIRED BY APPLICABLE LAW, THE DISCLAIMERS CONTAINED IN THIS ASSIGNMENT ARE "CONSPICUOUS" FOR THE PURPOSES OF SUCH APPLICABLE LAW.

8. Subrogation. To the extent permitted by law, Assignee shall be subrogated to Assignors' rights in and to representations, warranties and covenants given with respect to the

Assets. Assignors hereby grant and transfer to Assignee, its successors and assigns, to the extent so transferable and permitted by law, the benefit of and the right to enforce the covenants, representations and warranties, if any, which Assignors are entitled to enforce with respect to the Assets, but only to the extent not enforced by Assignors.

9. Successors and Assigns. This Assignment binds and inures to the benefit of Assignors and Assignee and their respective successors and assigns, and all obligations shall be a covenant running with the land. This Assignment is intended to be recorded and filed of record.

10. Exhibits. All exhibits attached hereto are hereby made part hereof and incorporated herein by this reference. References in such exhibits to instruments on file in the public records are notice of such instruments for all purposes. Unless provided otherwise, all recording references in such exhibits are to the appropriate records of the counties in which the Assets are located.

11. Governing Law. This Assignment and any arbitration or dispute resolution conducted pursuant hereto shall be construed in accordance with, and governed by, the laws of the State of Colorado without reference to the conflict of laws principles thereof.

12. Counterparts. This Assignment may be executed by Assignors and Assignee in any number of counterparts, each of which shall be deemed an original instrument, but all of which together shall constitute one and the same instrument.


