Dear Mr. Roehrs:

On February 27, 1989, we received a letter from Cross Timbers Production Company indicating that you had purchased their interest in the Houston No. 2-29 well which they in turn had acquired from Crown Central Petroleum Corporation. You were sent a copy of this letter by Cross Timbers, along with a copy of a letter requesting certain information by this office. As of the date of this letter we have received no correspondence from you.

The well appears to be temporarily abandoned having never produced oil or gas in commercial quantities. Rule 319 b. requires that any well found to be incapable of production must be plugged within 6 months thereafter unless time is extended upon written application of the owner. Should you wish to maintain the well as temporarily abandoned or operate the well, you should comply with the Rules and Regulations of the Commission including the filing of a Change of Operator form per Rule 310 and a Sundry Notice stating the intent to utilize the well per Rule 319 b..

In the event that you fail to respond to this letter, including the filing of the necessary reports and forms, by May 1, 1989, I will recommend that the Director require the operator of record, Crown Central Petroleum Corporation to plug and abandon the well. By photocopy of this letter, I am informing Crown Central of their obligations under the Rules and Regulations of the Colorado Oil and Gas Conservation


