1-3-84	0 hours	Moved in and rigged up.
1-4-84	5 hours	Dug deadmen. Unseated pump. Pulled 175 rods.
1-5-84	0 hours	Pulled rest of rods and tubing.
1-6-84	8 hours	Dug cellar. Ran sand from 6762' to 6670'. Loaded hole. Set in floor. Worked pipe to 10". Water truck, 4 hours.
1-9-84	8 hours	Ran 15 joints 1" tubing. No pit. Loaded rods and tubing. Dumped 5 sacks cement on sand.
1-10-84	8 hours	Had pit dug. Ran 45 joints tubing. Water truck, 7 hours. Hargus.
1-11-84	8 hours	Worked pipe. Pumped 27 bbls. oil. Pulled tubing. Worked pipe. Water truck, 5 hours. Pump job.
1-12-84	8 hours	Worked pipe to 60". Ran shots to 6057', 5760' and 5550'. Came loose. Pulled 17 joints.
1-13-84	0 hours	Pulled pipe, 168 total joints. Talled pipe.
1-16-84	4 hours	Tore out floor. Set 25 sacks cement from 210' to 165'. Filled with mud to 30'. Set 10 sacks cement to 3' below ground level. Welded on cap.
