Engineer	<p>The following note was placed in the well file for all of the Popham 4N64W03 1-20 Well Pad wells:</p> <p>It appears that the Carroll E Flack 1 (123-07211), was re-entered and re-completed by JR Oil in February, 1984 COGCC Doc No 131716. JR confirms that the Weld Co #2 was actually a recompletion of the Carrell E Flack 1 and not a new SPUD as defined by FERC. A Sundry 2/1984 Doc No 131712, approved to change Weld Co #2 to a Re-entry, instead of a new well. Other documentation seems to confirm this. The Well was PA'd 4/19/2016, by Noble Energy, thereby isolating the hydrocarbon producing zones from the water bearing formations, to satisfy Option 3 in the COA's.</p>	11/19/2016
