Comment:

The previous FIR conducted on 11/13/2019 required Operator to determine mitigating measures that would allow reclamation work to be conducted, as vegetation is not reflective of reference area vegetative levels.

On 11/19/2019, Operator provided documentation that vegetation monitoring was on-going and a vegetative assessment was performed on 9/16/2019. The assessment identified Kochia throughout the disturbance area (reclaim area) and Kochia was over represented compared to the surrounding reference area. Reclamation work was conducted by applying a broadleaf herbicide throughout the ~2.55 acres location on 9/23/2019. Therefore, the Operator has already completed the corrective action prior to the previous corrective action inspection.
