While there, I observed a temporarily abandoned wellhead.

During this inspection the following possible compliance issues were observed:

1. Weeds inside fencing that contains wellhead. Please removed to COMPLY WITH RULE 603.F. (Corrective Action Date: October 17, 2019) See attached photos #2,3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
