**Comments:**

SRC completed final reclamation for the well head, production facility, and access road to the well head 11/26/2019. SRC removed all existing road base, recontoured, added topsoil for proper elevations, deep ripped, disked, and left the ground ready for the land owner to plant crops. Well head, road and production facility are in irrigated farm ground so proper grading was achieved to ensure drainage of irrigation. The well head, production facility, and road are in its first growing season. SRC will continue to monitor the location for growth and will submit a final form 4 once comparative growth has been achieved. Attached is documentation of the reclamation procedure.
