Access road not being reclaimed and incomplete recontouring of Location are subject of the Variance Request.

Desirable perennial vegetation is establishing, though snow cover prevented detailed assessment. Stands of desiccated Canada & Russian thistle were noted on site. It does not appear that weed control was implemented this year. Weed monitoring & control program need to continue until site passes Final Reclamation. Refer to Photo Log attached.
