COMMENTS:

Pressure test was performed to 500psi for 15 min, but was not charted. Test was good. Well was TA as a safety shut-in for offset frac of Axis' (Bison's at the time) Houlihan 4-64 22A 21-1 HZ well. This well was completed in the Niobrara. Operations summary from safety shut-in is attached. Well will remain TA until a Form 6 is submitted to plug and abandon the well within the next six months. The well is shut to atmosphere with a RBP set at 7,960' and with a master valve at surface. MIT was performed 5/2/2019 and submitted.
