INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK) TO BE PERFORMED

This well completed as "D" sand oil producer with a Baker Model "N" bridge plug set at 4910'KB. It is now proposed to drill out the Baker Model "N" bridge plug at 4910 and clean out to total depth of 5055'KB. Run Baker Model "D" Retainer Production Packer and set at 4900'KB. Tops: "D" sand -4837 & "J" sand -4938. Run special Anchor seal Assembly on 2" Tubing and connect up to Production Packer. Run 1" Tubing and set in Anchor seal Assembly. Hook up dual zone well head equipment and place well on production for gas from "J" sand and oil from "D" sand.
