Comment: Stormwater CAs from previous RI Inspection have been Resolved. Structurally robust BMPs have been installed and site now appears stable and is handling high traffic volume at present.
Two concerns have developed:
1) Point where traffic turns into location from Office/Yards complex, traffic is cutting corner, rutting and degrading edge of Reclamation area; exclusion Bmp is needed.
2) Strip along East side of Access road as it enters Location needs defined BMP installed.

Corrective Action: Install sufficient/effective BMPs in accordance with, and monitoring per Good Engineering Practices per Rule 1002.f by 1/3/20 or when conditions permit where frozen ground inhibits installation.
