At time of inspection corrective actions appear to be addressed.</p> <p>At time of inspection I observed what appeared to be crew venting gas out the backside of the well head with rig running to relieve pressure to work on well. I spoke with KPK rig supervisor Rick Ramos if this was the safest way to perform the work he stated no, crew should have topped killed well with water. Crew immediately closed well and proceeded to top kill well.</p> <p>Weather conditions: Clear and location is muddy and has snow.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of inspection report.</p>	silverr	12/03/2019
