Comment:

We currently utilize a single mud cooler/chiller to lower the temperature of the mud on surface. By lowering the mud temperature we reduce odorous compounds leaving the mud. We are also adding 40 gal/day of Ecosorb to the drilling mud. Ecosorb is an odor neutralizer that attaches to odorous compounds in the mud and neutralizes their odors. Pursuant to Exhibit B of Extraction's executed Operator Agreement with the City and County of Broomfield COA 48-Odor "Operator is prohibited from masking odors from any oil and gas facility site by using masking fragrances."

Going forward we plan on adding a second mud chiller starting first thing tomorrow 5/16 to further reduce the temperature on surface and eliminate additional odors. We also plan on using an additional odor neutralizer called Odor-Armor from Benzaco Scientific. It acts in a similar manner as Ecosorb and other operators have had success with it in the area.
