This off location flowline has not been registered with COGCC; Operator has not submitted COGCC Form 44.</p> <p>Note: Operator has not registered any off location flowlines with COGCC; The Corrective Action outlined is applicable to all wells operated by Complete Energy Services with off location flowlines.</p>	
<u>Corrective Action:</u>	<p>Operator shall comply with the following COGCC rule(s):</p> <p>1101.a. (Partial) Off-Location Flowline Registration. (1) An operator must register an off-location flowline constructed on or after May 1, 2018, by submitting a Flowline Report, Form 44, to the Director within 30 days after the flowline is placed into service. An off location flowline in existence prior to May 1, 2018, must be registered by October 31, 2019. An off-location flowline registered as part of a produced water transfer system is not subject to this requirement.</p> <p>1101.c. (Partial) Crude Oil Transfer Line and Produced Water Transfer System Registration.</p> <p>(1) Registration. At least 10 days before beginning construction of a crude oil transfer line or produced water transfer system, an operator must register it by submitting a Flowline Report, Form 44, to the Director. The submittal must include a layout drawing sufficient to show its route, its crossings of public by-ways, road crossings, sensitive wildlife habitats, sensitive areas and natural and manmade watercourses and the surrounding topography. For a crude oil transfer line or produced water transfer system constructed before May 1, 2018, the operator must register it by submitting a Flowline Report, Form 44, to the Director by October 31, 2019.
