With workover rig performing maintenance</p> <p>During this inspection the following possible compliance issues were observed:</p> <p>Tracking pad: Rule 1002 f (2) F Corrective action date of 12-19-19 see photos 2,3,4</p> <p>Weather conditions: Clear location Muddy in spots</p> <p>Inspection due to odor complaint. Form 19 Doc#402251236 spill report has been filed with the COGCC. This may be a factor in complaint but at time of inspection spill and clean up has been addressed. After speaking with Mark Tibbs rig supervisor construction associated with the spill had just been complete a couple days prior to inspection.</p> <p>At time of inspection I spoke with Great Western Rig supervisor Mark Tibbs about tracking pad BMP failing and sediment being carried out to county road.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of inspection report.</p>	silverr	12/18/2019
