The removal of all equipment has not been performed; gravel remains throughout portions of the access road and location; access road has not been re-contoured or re-graded; compaction alleviation has not been performed throughout the access road and location.

Corrective Action:	Comply with Rule 1004.a. to remove all gravel, re-contour and re-grade the access road and location, and perform compaction alleviation. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
