This is a Reclamation Stormwater Inspection, prompted by notice of condition of Location access road diverting off Conn Creek Road. Access road is so degraded/ rutted/sloppy to make site appear inaccessible without further degradation of road and tracking onto Conn Creek Rd. Inspector did not attempt to access Location because of risk; therefore, this Insp only addresses this one Stormwater/Access issue. Operator was contacted and informed of issue and need for immediate Action.

Insp Doc#689703246 Dated 6/26/19 had CA addressing road conditions, which were resolved by Follow Up Insp 7/19/19; however this Inspection may be indicating that major road improvement work is indicated.
