Reportable spill found on location. Spill reported via phone call to Mr. Herschel Kennedy who was unaware of spill at the time of call. Some attempts to clean up impacted area had been made prior to inspection.

Emergency contact number on lease sign was not capable of contacting operator outside of normal business hours. Calls are currently transferred to office in Kansas.

Comment: Sign not posted or information inaccurate at well. Environmental inspector called emergency phone number listed on lease sign to report spill. Answering service transferred call to office in Kansas and who attempted to forward call to office in Houston. Operator representative stated Kansas office is not staffed 24 hours a day. Operator emergency contact number is required to be monitored 24 hours a day by personnel able to dispatch employees to the field to address emergency situations.

Corrective Action: Operator shall ensure calls to emergency number listed on lease signs are capable of contacting employees able to respond to emergency situations.
