1208-UP-235: The county should be Rio Blanco. On the pooling application, it is listed Rio Blanco in the body of the application, and just says Weld in the caption. Will this require an amendment or can we change in the Notice since it is listed correctly in the body?

1208-UP-233: These orders do not apply. They are for the Dakota, the application is for the Codell and/or Niobrara Applications.
