However, these facilities and pits were in service to a well acquired by Fifth Creek Energy and subsequently HighPoint in the merger of Fifth Creek Energy and Bill Barrett Corporation. (Bill Barrett Corporation changed its name to HighPoint Operating Corporation after the merger with Fifth Creek Energy). The produced well, Colorado Energy Federal 14-4 05-123-19618), produces to a tank battery (Facility ID 459260) located on Location ID 330368. This tank battery discharges water to three pits (258028, 58029, 258030) located on Location ID 409326. Locations 330368 and 409326 contain wells plugged by Ward Petroleum (05-123-18978 and 05-123-19088), but the produced facilities remained active.


