A hydrovac was used to remove all visual contamination. Soil samples will be taken to determine the extent of contamination. Excavation will be done once equipment is out of the way. We are unable to remove equipment at this time. Hand augering for soil samples will be collected for delineation when the ground thaws by 6/1/2019.

On 3-30-2018, two 10-foot long, 4-inch diameter horizontal screens were installed into an excavated pit that was approximately 15 feet long by 10 feet wide. The horizontal screens were installed as a soil vapor extraction unit. The screens were covered with pea gravel then granular carbon was placed on top of the pea gravel.

On January 2, 2019, five soil samples were obtained and five temporary monitoring wells were installed at the site. The soil samples were analyzed for TPH and BTEX. All soil samples (SB-1 through SB-5) were below the COGCC limit. A water sample was retrieved through the soil boring 5 (SB-5W) and analyzed for BTEX, the result was below COGCC standards.

On January 8, 2019, groundwater samples were retrieved from temporary wells 1 through 4 (SB-1W through SB-4W) and analyzed for BTEX. All samples were below Table 910-1 BTEX concentration levels.
