Three insitu chemical oxidation events were conducted (first, second and fourth quarter 2019). First quarter 2019, a total of 37 injection points were advanced and a total of 4,560 pounds of COGAC™ was injected. Second quarter 2019, a total of 30 injection points were advanced, and a total of 4,560 pounds of COGAC™ was injected. Fourth quarter 2019, a total of 15 injection points were advanced and a total of 2,200 pounds of COGAC™ was injected. Additional insitu chemical oxidation events will be completed during the first half of 2020 to remediate remaining petroleum hydrocarbon impacts.
