Well was spudded on November 6, 1977. After setting surface casing, well was drilled to total depth of 5047' and electric logs run. Drill stem tests were run in both the "D" and "J" Sands to evaluate shows. Results were negative so well was plugged and abandoned as follows:

A 20 sack cement plug was set from 85' to 125';
a 10 sack cement plug was set from surface to 30'.

Hole was filled with heavy mud.
