Comment **Previous FI inspection noted "Cellar open to all wells with no cover or fencing. Livestock and wild life at risk." with CA to Comply with the 1003.a. interim reclamation rules. Livestock Panels have been installed around Well line up which excludes livestock and larger wildlife from cellars. Configuration of concrete cellars still allows ingress of smaller Wildlife with no means of egress that Inspector could see in snow cover conditions. Other Operators have filled cellars with gravel or installed wildlife escape ramps in response to this concern.**
