While there, I observed a shut in pumpjack. During this inspection the following possible compliance issues were observed: 1. Containers at pumpjack and east of pumpjack next to electrical equipment. 2 containers contain unknown liquids. PLEASE REMOVE TO COMPLY WITH RULE 603.F. (Corrective Action Date: November 21, 2019) See attached photos #3-7. 2. Appears to be stained soil at front of pumpjack. Conduct maintenance on equipment, cleanup stained material and review self inspection processes in accordance to Rule 1002.F.(2).D.
